

\$5,000 NO-ESSAY GRAD SCHOOL SCHOLARSHIP BY SALLIE
SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

SPONSOR: SLM Education Services, LLC (“Sallie”) is the Sponsor of the Sweepstake. Entrants acknowledge and agree that they are subject to and consent to all notices posted online, including but not limited to the Sponsor’s Privacy Notice and Privacy Policy.

SWEEPSTAKES PERIOD: The **\$5,000 No-Essay Grad School Scholarship by Sallie Sweepstakes** (the “Sweepstakes”) begins at 12:00:01 AM Eastern Time (“ET”) Thursday, February 5, 2026 and ends at 11:59:59 PM ET on Thursday, December 31, 2026 (the “Sweepstakes Period”) and consists of four (4) segments (each a “Sweepstakes”) as set forth in the table below. Each Sweepstake has a corresponding entry period (“Sweepstakes Entry Period”). Sponsor’s computer is the official clock for this Sweepstakes.

Sweepstakes Entry Periods: There are four (4) Sweepstakes Entry Periods as set forth in the chart below. **Entries must be received during the listed Sweepstakes Entry Period to be eligible for the applicable Sweepstake. Non-winning Entries for any Sweepstake will not be rolled over to subsequent Sweepstakes.**

ELIGIBILITY: The \$5,000 No-Essay Grad School Scholarship by Sallie Sweepstakes is only open to legal residents of the 50 United States, the District of Columbia and any US Territory age 18 or older at the time of entry, and who meet one (1) of the four (4) following eligibility requirements at the time of entry: 1) a parent or guardian who currently has a student enrolled in an accredited college or university located within the United States; 2) a student who is currently enrolled in an accredited college or university located within the United States; 3) a parent or guardian who has a student who will enroll in an accredited college or university located in the United States within three (3) to six (6) months from the Sweepstakes Drawing Date for the applicable Sweepstakes; or 4) a student who will enroll in an accredited college or

university located in the United States within three (3) to six (6) months from the Sweepstakes Drawing Date for the applicable Sweepstakes (each an “Entrant”).

Void outside the U.S. and wherever prohibited by law. Employees of the Sponsor, SLM Education Services, LLC, and its parents, members, agencies, affiliates, and subsidiaries, and their immediate family members (spouse, parents, children and siblings, and their respective spouses) and persons living in the household of each are not eligible to participate. All federal, state and local laws and regulations apply.

ENTRY: There is one (1) method of Entry.

Method: Online Entry: Participants may enter by visiting the Sweepstakes Online Landing Page at <https://www.sallie.com/scholarships/grad-no-essay>, completing the online entry form and submitting to receive one (1) Sweepstakes Entry (the “Entry”) per Sweepstakes Entry Period.

Entries must be received within the listed Sweepstakes Entry Period and in compliance with these Rules to be eligible for that Sweepstakes and Sweepstakes Drawing. Please see the table above for the Sweepstakes and related Sweepstakes Entry Periods.

Limit: For each Sweepstakes, one (1) Entry per month during the applicable Sweepstakes Entry Period, and per email address. For Sweepstakes No. 1, with the Sweepstakes Entry Period of 02/01/2026 to 03/31/2026, Entrants may submit one Entry per month with a maximum of two (2) Entries per email address for this Sweepstake during the corresponding Sweepstakes Entry Period. For Sweepstakes Nos. 2, 3 and 4, Entrants may submit one Entry per month with a maximum of three (3) Entries per an email address per each Sweepstake and corresponding Sweepstakes Entry Period. If the Entrant desires to enter one (1) Entry per a Sweepstakes, then the Entrant may submit the Entry at any time during the corresponding Sweepstakes Entry Period. The second Entry must be received by Sponsor between November 1 and November 30, 2026. The third Entry must be received by Sponsor between December 1 and December 31, 2026. There shall be no more than one (1) Entry per month per Sweepstake, per Sweepstakes Period, per email. Any Entries received that are in violation of these time limits shall not be accepted and shall not be considered an eligible Entry.

RANDOM DRAWING: One (1) winner will be selected for each Sweepstake in a random drawing from among all eligible Entries received during that corresponding Sweepstakes Entry Period. The anticipated drawing date for each Sweepstake is listed in the table above. The drawings will be performed by an independent sweepstakes agency (“Administrator”), whose decisions are final and binding in all matters related to this Sweepstake.

WINNER NOTIFICATION, VERIFICATION, AND DISQUALIFICATION: Potential Grand Prize winner will be notified via email and/or phone within 30 days of the selection of a Grand Prize winner. The Grand Prize shall be sent to the student's college or university within 45 business days of verification of current enrollment of the Grand Prize winner or their student in an accredited college or university located within the United States. If the Grand Prize winner or their student cannot provide proof of current enrollment pursuant to the Verification and Proof of Enrollment section below, the Grand Prize winner shall be disqualified and shall no longer be eligible for and/or shall forfeit/be disqualified from the entirety of the Sweepstakes Grand Prizes.

Except where prohibited by law, the potential Grand Prize winner shall be disqualified and shall no longer be eligible for and/or shall forfeit/be disqualified from the entirety of any Sweepstakes Grand Prize (i) if Releases, as defined below, are not returned or returned as undeliverable, (ii) if the potential Grand Prize winner cannot accept or receive the Grand Prize for any reason, (iii) if the potential Grand Prize winner is not in compliance with these Official Rules or (iv) if any of the disqualifying criteria listed in these Rules are applicable. In the event the potential Grand Prize winner is disqualified, Administrator may select one (1) alternate winner.

Releases.

Except where prohibited by law, the potential Grand Prize winner will be required to sign and return, within seven (7) days of notification, an Affidavit of Eligibility, a Liability Waiver, and a Publicity Release (collectively, "the Releases"). These Releases will require, among other things, that the potential Grand Prize winner provide their social media handles and Social Security Number, as well as the name and information of the college or university in order to distribute the Grand Prize to the appropriate school. If the potential Grand Prize winner is a parent or guardian, they must also provide such information about their student and obtain the student's consent to a Publicity Release and Liability Waiver. Potential Grand Prize winners who are minors in their state of residence must have their parent or guardian execute the Releases.

Verification and Proof of Enrollment. Except where prohibited by law, the potential Grand Prize Winner will not be deemed a Grand Prize winner until Sponsor's receipt of the Releases, clearance of a background check, and confirmation that they are in compliance with these Official Rules. The potential Grand Prize winner must submit proof of their or their student's current or future confirmed enrollment (at the time of submission of proof) in an accredited college or university located within the United States within forty-five (45) days of notification of Grand Prize.

Failure to provide proof of confirmed enrollment within the time limits shall disqualify the potential Grand Prize winner and they shall no longer be eligible for and/or shall forfeit/be disqualified from the Sweepstakes Grand Prize.

Sponsor reserves the right to disqualify a potential Grand Prize winner on the basis of the findings of any Reputation Risks from such background check or if a potential Grand Prize winner fails to properly authorize and/or provide the required information in connection with such background check. If the potential Grand Prize winner is a parent or guardian then no background check is required for the parent or guardian but they must obtain consent from their student to have such background check performed on the student, and such background check shall be subject to the terms in this section.

PRIZE/APPROXIMATE RETAIL VALUE (“ARV”)/ODDS: During the Sweepstakes Period, there will be four (4) Grand Prizes available to be won, with a **total value of all Grand Prizes available to be won: \$20,000.00.**

No Grand Prize nor any monetary amount shall be sent or payable by Sponsor directly to the Grand Prize winner or their student.

Prizes are non-assignable and non-transferable. No substitution is permitted except if prize is unavailable, in which case a prize of equal or greater value will be awarded. No exchange or substitution of prizes, except at the sole discretion of the Sponsor.

The winner is responsible for all federal, state and local taxes, if applicable. Any other incidental expenses associated with the receipt and/or use of prize is the winner’s sole

responsibility. Except where prohibited by law, Entry and acceptance of a Grand Prize constitute permission to use winner's name, prize won, hometown, likeness, video tape, photographs, and statements for purposes of advertising, promotion and publicity (including online posting) in any and all media now or hereafter known throughout the world in perpetuity, without additional compensation, notification or permission.
